GENERAL RULES:

Setup of Exhibits will take place on Monday, August 7th and Tuesday, August 8th from 10:00 am to 6:00 pm.

Exhibits shall not be removed from the hall until Sunday, August 20th, 2023 from 8:00 am to 11:00 am.

No entries will be admitted after 6:00 pm on August 8, 2023.

All Rules and Regulations as found on page 7 will also apply to all classes and categories.

All articles must be the work of the exhibitor and strictly homemade. All canned goods must be from August 2022 to August 2023 and exhibited in colorless glass canning jars. Canned goods will be opened at discretion of judges. **Only listed varieties will be accepted.** Jars must be full and sealed. May be disqualified if older than August 2022.

All canned goods should be labeled as follows: Class, Category Number & Variety Number, name of product to be put on the side of jars; name and address on bottom of jars only. Ingredients in jars need to be uniform. Judged on color, uniformity & size.

Fifteen (15) entries within Dept. 1 will be required in order to receive 1 Season Pass, NO exceptions. Children under 12 who enter less than 15 items in Dept. 1 will receive one (1) day pass, NO exceptions.
