Booth Space

6. Electricity:

Operations that use power to cook or prepare anything will see a power surcharge added to their booth rent. Items that are put on display that are plugged in operate ie: to heat or to illuminate or broadcast will be considered for surcharge. An electric fan plugged in for personal cooling or a lamp for you to see are not considered for surcharge.

7. Insurance:

Vendor also needs to supply the fair with a certificate of insurance stating they have a general liability policy of \$1,000,000.00, with the Skowhegan State Fair listed as additional insured.

- Please note the fair reserves the right to determine final location due to space availability. Please remember available spaces may be limited.
- Returning Commodities:**
