Setup of Flower Exhibits will take place on Tuesday, August 6<sup>th</sup> from 1:00 pm to 7:00 pm.

***No entries will be admitted after 7:00 pm on August 6.***

Exhibits shall not be removed from the hall until Sunday, August 18<sup>th</sup> from 9:00 am to 11:00 am.

All Rules and Regulations as found on page 7 will also apply to all classes and categories.

This is an amateur flower & plant exhibit, professional florists may not enter in any classes. All flowers must be grown by the exhibitor. All entries must be listed on the Hall Entry Form prior to entering, any entries not listed will not be accepted.

All entries must arrive in a container that can hold water and container must belong to the exhibitor. Arrangements and displays may incorporate the use of artificial fruit or vegetables. Accessories may be included in the arrangement itself or as a separate addition.

***Artificial, wilted or dead flowers will NOT be accepted.***

Department of Conservation consider Purple Loosestrife an invasive species detrimental to native plants. All entries containing this species will be disqualified.

***Fifteen (15) entries within Dept. 2 will be required in order to receive 1 Season Pass, NO exceptions.***
